ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of the corporation is ALLTRADER BUSINESS SERVICE CORP.

ARTICLE II - DURATION

This corporation is to exist perpetually.

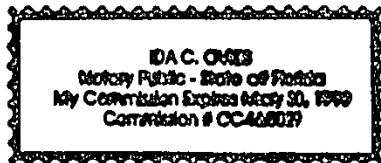
