

**ARTICLES OF INCORPORATION**  
**FOR**  
G M Postal Service and More, Inc

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act do hereby adopt the following articles of incorporation :

**ARTICLE ONE**

The name of the corporation is G M Postal Service and More, Inc

The duration of the corporation shall be perpetual.

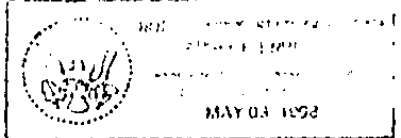


