

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is TEAM CANINE, INC.

ARTICLE II - INITIAL PRINCIPAL OFFICE

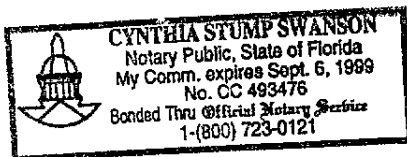
