

Pursuant to the provisions of section 617.1006, Florida Statutes, this corporation adopts the following articles of amendment to its articles of incorporation:

- 1. The Name of the corporation is SOLIMAR CONDOMINIUM ASSOCIATION, INC.
- 2. Article 10.1 is being amended to read as follows:

Number and Qualification. The property, business and affairs of the Association shall be managed by a board consisting of the number of directors determined in the manner provided by the By-Laws, but which shall consist of not less than three (3) directors. Directors need not be members of the Association.

- 3. Article 10.5 is being amended to read as follows:
