**SECOND:** The date of the amendment's adoption was August 31, 1998


**THIRD:** The amendment was approved by all of the shareholders and directors.

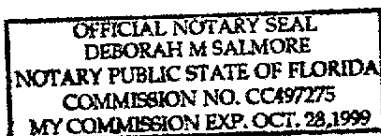


