

Article I

EFFECTIVE DATE

11-23-98

*Name.* The name of this Corporation is CHUCK BUSH AUTO REPAIR, INC.

Article II

*Principal Office.* The address of the principal office of the Corporation is 2525 N. Main Street, Gainesville, Florida 32609.

Article III

*Duration.* The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

Article IV


