The undersigned, acting as incorporators of a corporation under the Florida Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST

The name of the corporation will be:

SECOND

The period of duration of the corporation will be perpetual.

THIRD

The purpose of the Corporation will be:

- a. To establish a learning center with high standards of excellence and education by providing GED preparation and job training.
- b. To provide a wide range of economic development initiatives for low and moderate income residents in the targeted area.
- c. To eliminate slum and blight.
- d. To provide after school care programs for area youths.
- e. To provide incubator programs for the uplifting of the community.
- f. To develop skill banks utilizing the skills of the elderly and provide programs to support the elderly and disabled.

FOURTH

The address of the initial registered office of the corporation will be 611 Pine Street, Post Office Box 38, Bronson, Florida, 32621-0038, and the initial registered agent at such address will be Mr. Robert L. Williams, Executive Director.

SEVENTH

The Directors will adopt the initial bylaws of the corporation. The powers to alter, amend, or repeal the bylaws of the corporation and to adopt new bylaws is reserved to the Directors.

EIGHTH

The Levy County Housing Authority Core Group, Inc. personnel thereof will respect and not act contrary to the local governing body.

NINTH

Said corporation is organized exclusively for educational and charitable purposes with the meaning of the 501 (C) 3 of the Internal Revenue Code of 1986, including, for such purpose, the making of distributions to organizations that qualify as exempt organizations under section 501 (C) 3 of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law)

Notwithstanding any other provision of these articles, this organization will not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (C) 3 of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law.

Upon the dissolution of the corporation, assets will be distributed for one or more exempt purposes with the meaning of section 501 (C) 3 of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or will be distributed to the federal, state, or local government for a public purpose. The Circuit Court, of the county in which the principal office of the corporation is then located exclusively for such purposes will dispose of any such assets not so disposed.

THE UNDERSIGNED, being the incorporators named, for the purpose of forming a nonprofit corporation under the Florida Nonprofit Corporation Act, make this certificate, declaring and certifying hereby that this is my/our act and deed and that the facts set forth herein are true, in witness of which I/we hereunto have set my/our hand(s) this 21 day of Sept, 1999.
