**ARTICLES OF INCORPORATION
OF

(a Florida corporation)

THE UNDERSIGNED, acting as sole incorporator of AFRICAN AMERICAN LENDERS.COM, INC., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

Initial Registered Office and Agent




