BE IT KNOWN, on this the 2nd day of October, 2000 before me, the undersigned notary public, personally appeared the subscriber hereto, Wanda G. House both of full age of majority and domiciled in Broward County, who declare before me and the undersigned competent witnesses that they availing themselves of the provisions of the Florida General Corporation Act, does hereby form a corporation under and in accordance with the following Articles of Incorporation.

ARTICLE I. NAME

The name of this corporation shall be International Investigations, Inc.

ARTICLE II. PURPOSE

The purpose of this corporation is to engage in any lawful activity for which a corporation may be formed under the Florida General Corporation Act of the State of Florida.

ARTICLE III. DURATION

The duration of this corporation shall be in perpetuity or such maximum period as may be allowed and authorized by the State of Florida.

ARTICLE VI. CAPITAL

The corporation has the authority to issue an aggregate of ten thousand (10,000) shares of capital stock, all of which are designated common stock having no par value. The Board of Directors shall fix the terms and conditions of sale and the time for payment of all stock sold.

ARTICLE VII. VOTING RIGHTS

All voting rights at the stockholders' meetings are vested in the shareholders of this corporation and each stockholder shall be entitled to one vote either in person or by proxy for each share of stock standing in her or his name on the books of the corporation.

Whenever the affirmative vote of the shareholders is required to authorize or constitute corporate action, the consent in writing to such action signed only by the shareholders holding the proportion of the total voting power on the question which is required by law or by these Articles whichever requirement is higher, shall be sufficient for the purpose without the necessity for a meeting of the shareholders.

ARTICLE IX. DIRECTORS

The number of the directors of this corporation shall be such number, not less than one nor more than five, as shall be elected by the shareholders. Any director absent from a meeting of the Board of Directors or of any committee thereof may be represented by any other director according to the written instructions, general or specific, of the absent director.



The Articles of Incorporation of this corporation may not be amended except by an affirmative vote at least 51% of the shareholders so entitled to vote on any such amendment.

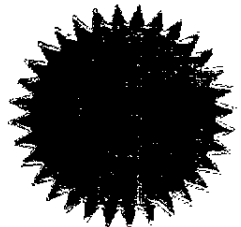
