- ONE:** The name and address of this principal corporation is Chaires Community Life Enrichment Center, Inc. 5755 Chaires Cross Road, Tallahassee, Florida 32311 in Leon County. The corporation is organized pursuant to the **FLORIDA** Nonprofit Corporation Code.
- TWO:** This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of but shall not be limited to: Mentoring, After School Program, Job Training, Job Placement, HIV/AIDS, Counseling, Chemical Dependency, Day Treatment, Spousal Abuse, Seminars, Workshops, Tutoring, and other programs to aid those who are in need.
- THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.
