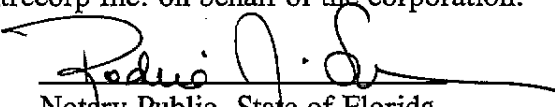
3. The foregoing amendment was adopted by the Board of Directors of this corporation on June 18, 2001, without Shareholder action. Shareholder action was not required.
