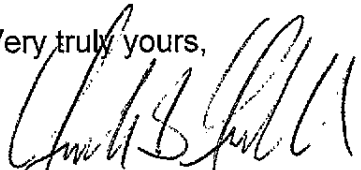

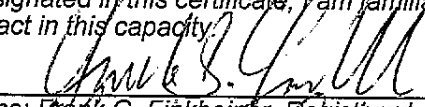
**ARTICLE IX: PREEMPTIVE RIGHTS**

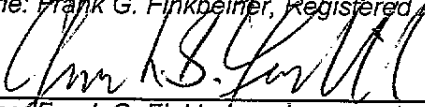
The Shareholders of the corporation shall have preemptive rights to acquire their
