**ARTICLES OF INCORPORATION**  
**OF**  
**SUZANNE R. SWIETNICKI, M.D., P.A.**

The undersigned, an individual licensed to practice medicine in the State of Florida and acting as incorporator, hereby adopts these Articles of Incorporation for the purpose of organizing a Professional Corporation pursuant to the provisions of the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes (the "Act") and other applicable laws of the State of Florida.

**ARTICLE I—NAME**

The name of the Corporation is: **Suzanne R. Swietnicki, M.D., P.A.**

**ARTICLE II—PRINCIPAL OFFICE**

The principal place of business and mailing address of this Corporation is as follows:

**ARTICLE III—PURPOSE**

The purpose for which the Corporation is organized is as follows:

A. To render "professional services" within the meaning of the Act, in the practice of medicine, through its shareholders, officers, employees and agents who are duly licensed to practice medicine in the State of Florida.

B. To have and exercise all powers conferred by the Act and the laws of the State of Florida upon professional service corporations.

C. To do any and all things authorized by this Article to the same extent as a natural person might or could do.

**ARTICLE IV—CAPITAL STOCK**

This Corporation is authorized to issue 100,000 shares of \$0.01 par value common stock. Shares of the Corporation's common stock shall be issued only to professional corporations (as defined in the Act), professional limited liability

companies (as defined in the Act), and individuals who are duly licensed to practice medicine in the State of Florida.

#### **ARTICLE V—REGISTERED OFFICE AND AGENT**


#### **ARTICLE VII—DISQUALIFICATION**

This Corporation shall have perpetual existence commencing May 13, 2002.


