ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation not for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

Name

The name of the corporation shall be: Folk Bosnian Dance Ensemble, Inc., Ljiljan.

**ARTICLE II**

Principal Place of Business & Mailing Address

**ARTICLE III**

Purpose

The purpose for which the corporation is organized is to provide the overall vision and preservation of Bosnian dance to be historically accurate and to convey the context in which Bosnian dances were originally done by teaching children between the ages of five (5) to eighteen (18). We also intend on conveying the importance of the Bosnian community's cultures and the upkeep of Bosnian traditions by also teaching the proper use of Bosnian language.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 © (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

**ARTICLE IV**

Manner in Which Directors are Elected or Appointed

The manner in which the directors are elected or appointed is to be specified in the Bylaws of the Corporation.

## ARTICLE VIII

### Powers of the Corporation

All the powers enumerated herein whether expressed or implied, shall be exercised exclusively for religious, charitable, educational and scientific purposes and shall be limited in such a manner that the corporation shall qualify as an exempt organization under Section 501(C) (3) or the Internal Revenue Code of 1964 and applicable state tax provisions as there are currently and shall hereinafter be in force and effect.

The corporation shall have one class of membership. The Board of Directors shall define qualifications for membership to be included in the bylaws.

No part of the income or profit of the corporation shall be distributable to its members, directors, or officers. Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of, or provision for the payment of, all debts and liabilities of the Corporation, shall be distributed to an organization and used exclusively for charitable, religious, benevolent, educational, or similar purposes.

## ARTICLE IX

### Description of Facility

Said organization will conduct activity of Bosnian Dance from a 12 x 12 room located at 4500 Baymeadows Road, #171, Jacksonville, Fl 32217, where Erdin Salcin, president of said organization resides.

## ARTICLE X

### Facility Usage

Said organization is located in the Salcin residence. No other activity will take place other than that of the Folk Bosnian Dance Ensemble, Inc., Ljiljan., provided from the organization. The only member of the organization that will actually reside at the same address is Erdin Salcin.

## ARTICLE XI

### Description of Organization's Staff

*Erdin Salcin* – President of said organization has extended knowledge of Bosnian traditions and historical cultures to teach to the students who apply. Erdin is a volunteer and will receive no monetary compensation for his services. Responsibilities will include that of dance instruction, Bosnian language lessons, administrative services, and provide teachings and counsel of the Bosnian traditions.

*Halid Cejvanovic* – Vice President of said organization has extended knowledge of Bosnian traditions and extended experience of Bosnian dance culture. Halid is a volunteer and will receive no monetary compensation for his services. Responsibilities will include that of dance instruction, Bosnian language lessons, administrative services, assisting president in dance instruction, provide teachings of Bosnian culture and the set up of dance recitals.

*Salcin Bernada* – Secretary / Treasurer of said organization has extended knowledge of Bosnian traditions and holds experience in various customs of the Bosnian ways. Salcin is a volunteer and will receive no monetary compensation for her services. Responsibilities will include that of Bosnian language lessons, administrative services, costume designer, the receiving of any donations that will go towards any fees for dance recitals and dance costumes.

## **ARTICLE XII**

### **Distributable Earnings**

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on or propaganda or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) and political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 © (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 © (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

## **ARTICLE XIII**

### **Payment for Services**

No payment will be required to said organization from recipients.

## **ARTICLE XIII**

### **Bylaws**

Said organization has no bylaws at this time.

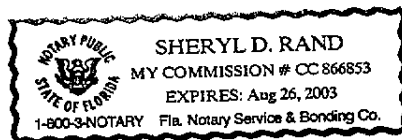
