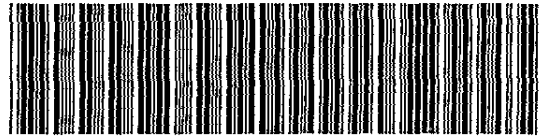

ARTICLE I -- NAME OF CORPORATION


