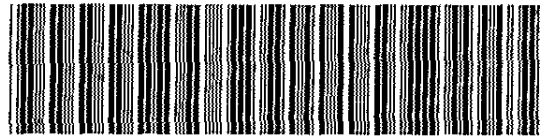

NATIONAL MEDICAL TELEVISION NETWORK, INC., a Florida corporation (the "Corporation"), hereby certified as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article I in its entirety and by substituting, in lieu thereof, the following:

**"ARTICLE I**

**Corporate Name and Principal Office**

The name of this corporation is African American Medical Network, Inc. and its principal office and mailing address is 6601 Center Drive West, Suite 521, Los Angeles, CA 90045."

2. The foregoing amendment shall become effective as of the close of business on the date these Articles of Amendment are approved by the Florida Department of State and all filing fees then due have been paid, all in accordance with the laws of the State of Florida.

3. The amendment recited in Section 1 above has been duly adopted in accordance with the provisions of Chapter 607, Florida Statutes, by the Board of Directors of the Corporation who adopted a resolution setting forth such amendment and declaring its advisability and directing that such amendment be considered by the Shareholders of the Corporation; and by a majority in interest of the Corporation's common voting stock having voted in favor thereof by written action dated April 28, 2004, which said votes cast for the amendment were sufficient for approval.


