ARTICLES OF ORGANIZATION

ARTICLE I. NAME

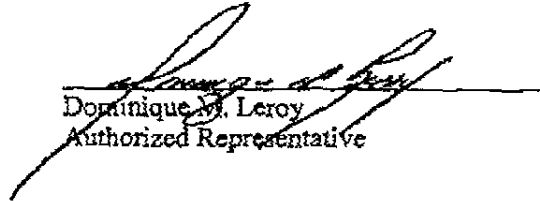

ARTICLE VII. AMENDMENT

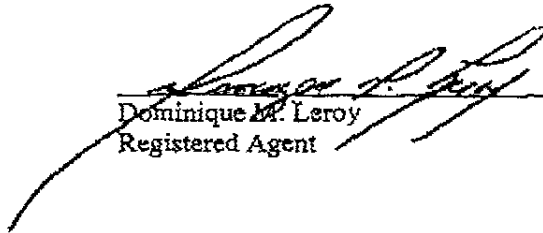
