ARTICLE V**REGISTERED OFFICE AND AGENT**

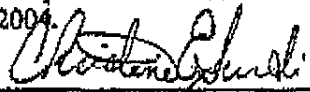

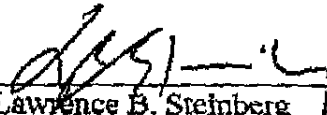
