**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF ORGANIZATION OF  
PEREZ-ABREU, AGUERREBERE & SUEIRO, P.L.**

These Articles of Amendment amend the Articles of Organization of Perez-Abreu, Aguerreberere & Sueiro, P.L. (the "Company") as filed with the Department of State, Division of Corporations of Florida on August 24, 1999.

1. The name of the Company is Perez-Abreu, Aguerreberere & Sueiro, P.L.
2. These Articles of Amendment were adopted by the Company.
3. Article I of the Articles of Organization of the Company is hereby amended to read in its entirety as follows:
