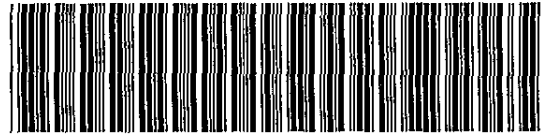


ARTICLE VI- Admission of Additional Members:




