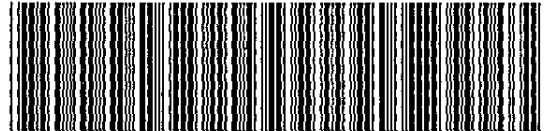

The undersigned, for purposes of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is: Seney Enterprises, Inc.

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida, and to effectuate such purposes, may act in any capacity including as an agent or attorney-in-fact for any person or entity.

ARTICLE III. CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of common stock, with a par value of one dollar (\$1.00), which shall be designated "Common Shares".


ARTICLE VIII. MANAGEMENT OF CORPORATION BY SHAREHOLDERS

The term of existence of the corporation is perpetual.



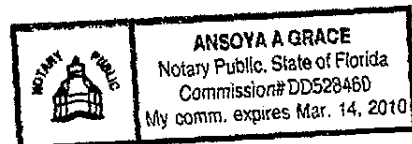
