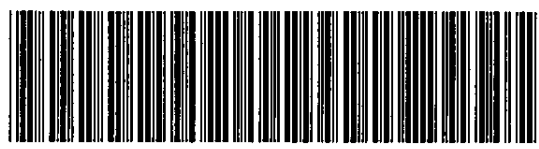

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendments to its Articles of Incorporation:

**AMENDMENTS ADOPTED:**

**ARTICLE I**

The name of the corporation shall be: Bay Taxpayers, Inc., a not-for-profit corporation. The principal place of business of this corporation shall be: 433 Oak Avenue, Panama City, Florida 32401.
