The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name of the corporation is Bymer, Inc. (the "Corporation").

SECOND: The street address, wherever located, of the principal office of the Corporation is Blakesberg & Company CPA's, 951 S.W. 4th Avenue, Boca Raton, Florida 33432-5803.

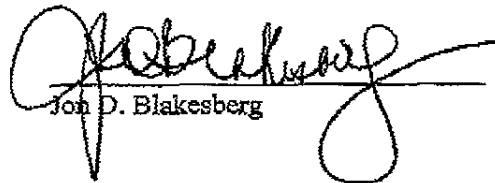

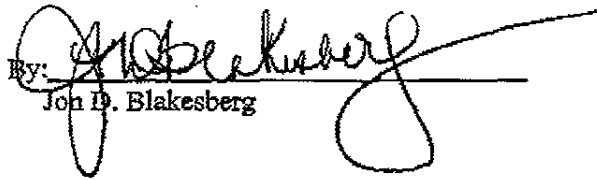
SEVENTH: The duration of the corporation shall be perpetual.
