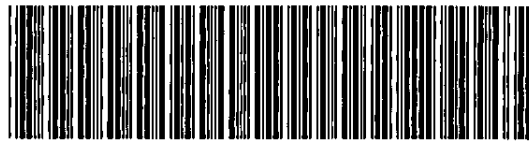



**ARTICLES OF ORGANIZATION OF
CU GRIDCO, LLC**

Article I

The name of the limited liability company ("Company") is CU GRIDCO, LLC, LLC.

Article II


Article VII


Article VIII


