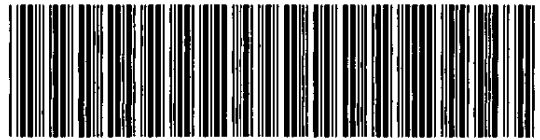

ARTICLE I - NAME

The name of this corporation shall be CUT-N-EDGE LANDSCAPING, INC., and the address of the principal office of the corporation is 652 Dartford Ct., DeBary, FL 32713

ARTICLE II - DURATION

The term of existence of this corporation shall be perpetual.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of conducting any and all lawful business.


ARTICLE IV - CAPITAL STOCK

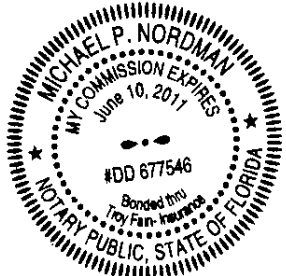



