**AMENDED AND RESTATED ARTICLES OF ORGANIZATION**

The undersigned, being a duly authorized representative of a member, desiring to amend and restate the articles of organization of this limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Amended and Restated Articles of Organization:

**ARTICLE I. NAME / FILING DATE**

The name of the limited liability company is **ALL AMERICAN COACHES & MORE LLC** (the "Company"). The Articles of Organization of the Company were filed on September 25, 2008, and assigned document number **L08000092675**.

**ARTICLE II. ADDRESS**

The principal office and mailing address of the Company is:

**ARTICLE III. REGISTERED AGENT AND OFFICE**

**ARTICLE IV. MANAGEMENT**

**ARTICLE VII. ADDITIONAL MEMBERS**

The effective date of these Amended and Restated Articles of Organization is the date that they are filed with the Florida Department of State.


