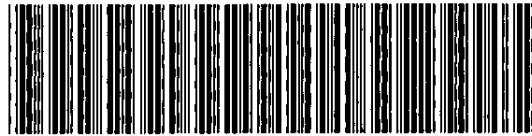

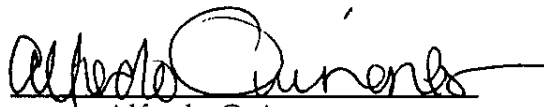
IX - BY-LAWS
