


4. Article V of the Articles of Organization of the Company is amended to revise the names and addresses of the manager of the Company to:

6. The amendment of the article of organization was approved by all members on September 29, 2009. The number of votes cast for the amendment was sufficient for approval.



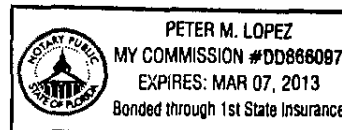
