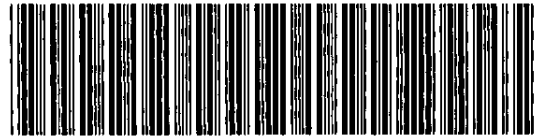

1) Board of Directors. As permitted by Section 607.0732 of the Act and agreed between by all current shareholders of the Corporation, the Corporation shall not have a Board of Directors, and all powers and responsibilities that the Act, the Articles of Incorporation of the Corporation and any other laws vest into the Board of Directors shall be vested into the Shareholders.

2) Officer. The Corporation shall have a Sales Manager as the sole officer for the Corporation. The Sales Manager shall be elected by a majority of votes casted by the Shareholders, and can be replaced at any time by a majority of votes by the Shareholders. The Sales Manager shall act as instructed in writing by the Corporation's shareholders. Therefore the powers and authority of the Sales Manager to act on behalf of the Corporation and bind the same shall be limited to the specific written instructions that the Shareholders will, from time to time, provide to the Sales Manager. The Shareholders may modify or revoke those instructions at any time.
