**ARTICLE I**

**ARTICLE V**



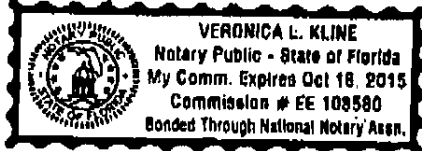


