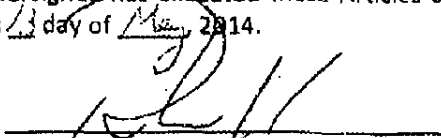
FIRST: The Articles of Organization of the Company were filed on May 13, 2013 and assigned Florida document number L13000069787.
