Melbourne Makerspace is organized to promote the scientific and educational advancement of the community through the art of creation over multiple disciplines, including Science, Technology, Engineering, Art, and Mathematics without the motivation for profit.

Change to Article IV

The manner in which directors are elected or appoint is:

By a vote of the general membership in the presence of a quorum. Directors shall be elected in staggered terms of 1 to 3 years. One third of the directors shall be elected for a 3 year term, one third will be elected for a 2 year term, and one third shall be elected for a one year term. In the case of the number of directors not being divided evenly by one third, the number of 1 year terms shall be reduced.


