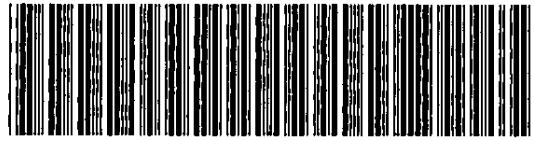

ARTICLE I. NAME

The name of this corporation is CRESPI MARKETING INC.




