**ARTICLES OF ORGANIZATION

1. Name. The name of this limited liability company is **1023 COLUMBUS, LLC**, a Florida limited liability company (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

4. Place of Principal Office. The mailing and street address of the Company's principal office is **1023 Columbus Drive, Tampa, FL 33605**.


