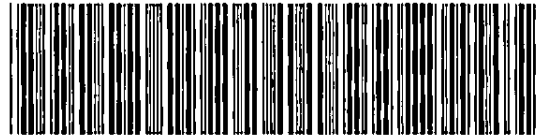



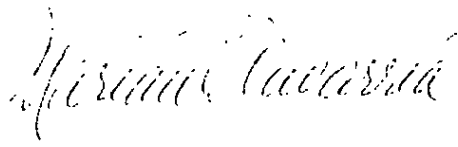
This certificate is issued by the *Servicio Nacional Integrado de Administración Aduanera y Tributaria* (National Integrated Service of Customs and Tax Administration) of the Bolivarian Republic of Venezuela.

The certification process in Venezuela is done strictly online, and no printed originals are issued. Once the online request is completed and the corporation is verified, the online system produces a digital certificate, which is what I am enclosing, in order to request the certificate of Status.

This same non-profit was once registered in the US in 1993, in Baltimore, Maryland, and was issued EIN 98-01 36863 (Copy attached). Unfortunately, it was not renewed for many years. We have been active internationally, and in the US, we have filed our taxes yearly, with no interruption.

I hope this explanation is helpful.

Based on information supplied and assuming your operations will be as stated in your application for recognition of exemption, we have determined you are exempt from federal income tax under section 501(a) of the Internal Revenue Code as an organization described in section 501(c)(3) from and after the effective date shown above.
