1. Article I- Name:



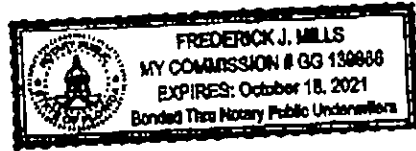
