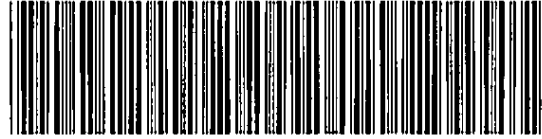

Article III

a. Molina's Wildlife Rescue, Inc. is organized exclusively for a charitable purpose under Section 501(c)3 of the Internal Revenue Service code to

provide rescue, rehabilitation and release of our native wildlife.

b. No part of the net earning of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private

person except to pay our participant veterinarian for medical care or surgeries of rescued wildlife or to buy caging and equipment necessary for

keeping the animals while under rehabilitation. This organization will not participate in any political campaign nor will influence legislation. This organization will not engage in other activities other than the ones mentioned above to rescue, rehabilitate and release our native wildlife.

c. Upon dissolution of the organization, assets will be distributed for one of more exempt purposes within the meaning of the section 501(c)3 of the Internal Revenue Service code, or corresponding sections of any further federal taxes code, or will be distributed to the Federal government or to the state and local government. Any other assets will be used to pay any remaining balance to veterinarians for services provided to the rescue wildlife animals.
