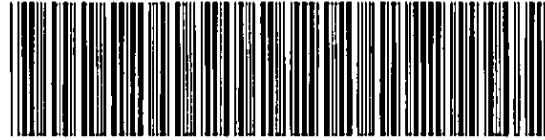

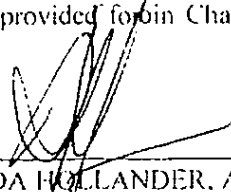
ARTICLE 5
