**ARTICLES OF INCORPORATION  
OF  
FUNDACION LIBERTAD Y DESARROLLO, INC.**

The undersigned, for the purpose of forming a Florida not-for-profit corporation under Chapter 617 of the Florida Statutes, and Section 501(c)(3) of the Internal Revenue Code of 1986<sup>1</sup>, and in his capacity as the Incorporator of FUNDACION LIBERTAD Y DESARROLLO, INC., hereby submits the following Articles of Incorporation:

**ARTICLE I**  
**NAME**

The name of the Corporation is FUNDACION LIBERTAD Y DESARROLLO, INC. (the "Corporation").

**ARTICLE II**  
**INITIAL PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

The Corporation's initial business and mailing address shall be:

Miami, Florida 33131

The Board of Directors may from time to time move the principal place of business and mailing address office of the Corporation to any other addresses in the State of Florida.

**ARTICLE III**  
**COMMENCEMENT OF EXISTENCE**

The existence of the Corporation shall commence with the filing of these Articles of Incorporation with the Florida Department of State.

**ARTICLE IV**  
**DURATION OF EXISTENCE**

The Corporation shall have perpetual existence.

**ARTICLE V**  
**PURPOSES**

The purposes for which the Corporation is formed are exclusively for charitable, religious, educational, and scientific purposes, within the meaning of Section 501(c)(3) of the U.S. Internal Revenue Code of 1986, as amended (the Code) and any rulings or regulations thereunder, or the corresponding provisions of any future internal revenue law

of the United States of America (the "Revenue Laws"), including, but not limited to, increasing awareness regarding sustainable democratic governments in Guatemala and throughout Central America and in the furtherance of such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. In carrying out such purposes, the Corporation shall have all of the powers and authorities granted by statute and law, including the power and authority to accept gifts, devise and other contributions for charitable purposes, to hold and administer the funds and properties received and to expend, contribute and otherwise dispose of funds or properties for charitable purposes either directly or by contribution to other Code Section 501(c)(3) organizations organized and operated exclusively for charitable purposes; provided, however, said powers and authorities shall be exercised only in furtherance of charitable purposes.

#### ARTICLE VI POWERS

The Corporation shall have the power, either directly or indirectly, either alone or in conjunction or in cooperation with others, to do any and all lawful acts and things and to engage in any and all lawful activities which may be necessary, useful, desirable, suitable or proper for the furtherance, accomplishment, fostering or attainment of any or all of the purposes for which the Corporation is organized, and to aid or assist other organizations whose activities are such as to further accomplish, foster or attain any of such purposes. Notwithstanding anything herein to the contrary, the Corporation shall exercise only such powers as are set forth in furtherance of the exempt purposes of organizations described in Code Section 501(c)(3) (or any corresponding provisions of any future Revenue Laws), including any rulings and regulations thereunder.

#### ARTICLE VII MEMBERSHIP

The Corporation shall have no members.

#### ARTICLE VIII DIRECTORS

The affairs of the Corporation shall be managed by a Board of Directors, members of which shall be elected in accordance with Bylaws adopted for the Corporation. The number of members of the Board of Directors shall be fixed as set forth in Bylaws adopted for the Corporation; provided, however, the Corporation shall never have less than three (3) members of the Board of Directors. The first Board of Directors, consisting of those persons (but not less than three (3)) who shall serve until their successors have been duly elected and qualified, shall be appointed by the incorporator pursuant to Section 617.0205, Florida Statutes.

#### ARTICLE IX OFFICERS

The officers of the Corporation shall be those officers as may be provided by Bylaws adopted by the Board of Directors for the Corporation. Officers shall be elected by the Board of Directors in the manner set forth in Bylaws.

ARTICLE XI  
BYLAWS

The Board of Directors shall adopt such Bylaws for the conduct of the Corporation's business and for the carrying out of the Corporation's purposes as the Board of Directors may deem necessary from time to time.

ARTICLE XII  
AMENDMENTS

Amendments to these Articles of Incorporation shall be proposed by resolution of the Board of Directors of the Corporation and shall be approved by the Board of Directors by a majority vote of a quorum present at a meeting duly called in accordance with Bylaws adopted by the Board of Directors for the Corporation.

ARTICLE XIII  
LIMITATIONS ON ACTIONS

All of the assets and earnings of the Corporation shall be used exclusively for the exempt purposes hereinabove set forth, including the payment of expenses incidental thereto. No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to any directors, trustees, officers or any other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make distributions and payments in furtherance of the purposes set forth above. No substantial part of the Corporation's activity shall be for the carrying on of a program of propaganda or otherwise attempting to influence legislation, except as otherwise provided in Code Section 501(h) (or corresponding provisions of any subsequent Revenue Laws); and the Corporation shall not participate in or interfere or intervene with (including the publication or distribution of statements regarding) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from U.S. federal income taxation under Code Section 501(c)(3) (or corresponding provisions of any subsequent Revenue Laws) or any organization, contributions to which are deductible under Code Section 170(c)(2) (or corresponding provisions of any subsequent Revenue Laws). The Corporation shall have no capital stock, pay no dividends, and distribute no part of its net income or assets to any directors, trustees or officers or any other private persons, and the private property of any directors, trustees or officers or any other private person shall not be liable for the debts of the Corporation.

In particular, but without limitation of the generality of the foregoing paragraph, during such time as the Corporation may be considered a private foundation as defined in

Code Section 509(a) (or corresponding provisions of any subsequent Revenue Laws), it shall not fail to distribute its income for each taxable year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Code Section 4942 (or corresponding provisions of any subsequent Revenue Laws); engage in any act of self-dealing as defined in Code Section 4941(d) (or corresponding provisions of by subsequent Revenue Laws); retain any excess business holdings as defined in Code Section 4943(c) (or corresponding provisions of any subsequent Revenue Laws); make any investment in such manner as to subject it to tax under Code Section 4944 (or corresponding provisions of any subsequent Revenue Laws); or make any taxable expenditures as defined in Code Section 4945(d) (or corresponding provisions of any subsequent Revenue Laws).


ARTICLE XIV  
DISSOLUTION

Upon dissolution of the Corporation, all of its assets remaining after payment of or provision for all liabilities of the including costs and expenses of such dissolution, shall be utilized exclusively for the exempt purposes of the Corporation or distributed to an organization described in and qualified under Code Section 501(c)(3) (or the corresponding provisions of any future Revenue Law), as shall be selected by the last Board of Directors of the Corporation. None of the assets will be distributed to any director, trustee or officer of the Corporation or any other private person. Any such assets not so disposed of shall be disposed of by the court of common pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine which are organized and operated exclusively for such purposes.

ARTICLE XV  
INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Corporation is 201 S. Biscayne Boulevard, Suite 800, Miami, Florida 33131, and the name of the initial registered agent at such address is LAW CENTER OF FLORIDA, INC.


