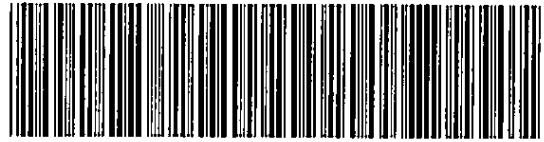



ARTICLE VII - OWNERSHIP

A. OWNERSHIP AND PARTICIPATION

Ownership of Ally Telecommunications LLC's (the Company) Capital, and participation in the Company's profits, if any, and losses, if any, (the ownership and participation interests) are, in equal shares, as follows:

- a) Ramon Pablo Jueguen (Jueguen) – 33.333% of the Company's ownership and participation interests;
- b) Johan Marcel Ramirez Restrepo (Ramirez) – 33.333% of the Company's ownership and participation interests;
- c) Juan Carlos Santamaria Rodriguez (Santamaria) - 33.333% of the Company's ownership and participation interests.

Together, Jueguen, Ramirez and Santamaria are the Company's only shareholders, in equal shares of the Company's ownership and participation interests.
