**ARTICLES OF ORGANIZATION  
OF

The undersigned, Ricky L. Gay, a natural person competent to contract and an authorized representative of JCRLG, LLC, hereby presents these Articles of Organization as the Articles of Organization of JCRLG, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I – NAME**

The name of the limited liability company is JCRLG, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II – PRINCIPAL OFFICE ADDRESS**

The street and mailing address of the Company's initial principal office is 297 Ketch Court, Destin, Florida 32541.

**ARTICLE III – PURPOSE AND POWERS**

The Company shall be managed by one or more managers in accordance with the terms of the Operating Agreement for the Company. The names and addresses of the initial managers of the Company are as follows:




