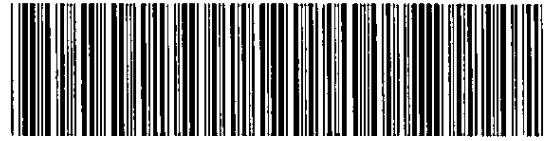

**FIRST AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
DICSA AMERICA LLC**
(Pursuant to Chapter 605 of the Florida Revised Limited Liability Company Act)

DICSA America LLC, a limited liability company organized and existing under and by virtue of the Florida Revised Limited Liability Company Act,

DOES HEREBY CERTIFY:

1. That the name of this company is DICSA America LLC, and that this company was originally incorporated pursuant to the Florida Revised Limited Liability Company Act on February 23, 2018, under the name DICSA America LLC.
2. That the sole member of DICSA America LLC duly resolved to amend and restate the Articles of Organization of this company, declaring said amendment and restatement to be advisable and in the best interests of this company and its sole member, which resolution setting forth the proposed amendment and restatement is as follows:

RESOLVED, that the Articles of Organization of this company be amended and restated in its entirety to read as follows:

ARTICLE I: NAME

The name of the Florida limited liability company is DICSA AMERICA LLC (the "Company").

ARTICLE II: ADDRESS

ARTICLE IV: EFFECTIVE DATE AND TIME

The effective date and time of these Amended and Restated Articles of Organization shall be the date and time that these Amended and Restated Articles of Organization are filed with the Florida Department of State, Division of Corporations.

ARTICLE V: PURPOSE

The Company is being formed for the purpose of transacting any and all lawful business for which a limited liability company may be organized under the Florida Revised Limited Liability Company Act.

ARTICLE VI: DURATION

The Company has been formed for an indefinite duration.

ARTICLE VII: MANAGEMENT

The Company will be manager-managed.

ARTICLE VIII: TRANSFERABILITY OF MEMBERSHIP INTERESTS

No members shall have the right to assign their membership interests in the Company without the written agreement of all of the membership interests, unless otherwise provided in the Company's Operating Agreement. If the assignment is not approved by all of the membership interests, the assignee shall have no right to become a member, to participate in the management of the Company, or to exercise any other rights or powers of a member. The assignee shall merely be entitled to receive the share of profits and other distributions and the allocation of income, gain, loss deduction, credit or similar item to which the assignor was entitled, to the extent assigned.

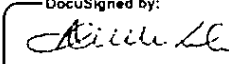
ARTICLE IX: DISTRIBUTION OF PROFITS

Unless otherwise provided in the Company's Operating Agreement, there shall not be any distribution of profits unless each separate distribution is approved by the affirmative vote of members who own more than 50% of the voting interest in the Company. The voting members shall have complete discretion on when and if to approve any distribution of profits.

In accordance with Section 605.0203(1)(b) of the Florida Revised Limited Liability Company Act, the execution of this document constitutes an affirmation under the penalties of perjury that the facts stated herein are true. I am aware that any false information submitted in a document to the Florida Department of State constitutes a third-degree felony as provided for in Section 817.155 of the Florida Statutes.
