
This letter is to notify you that Mr. Brian K. Waxman fraudulently completed a filing for our Foreign Limited Liability Company Annual Report on February 8, 2025. In that filing, he fraudulently reported himself to be the manager of our company. Additionally, Mr. Waxman falsely reported the name and address of the A & W Management, LLC's registered agent to be: Corporation Service Company, 1201 Hays Street, Tallahassee, FL 32301. His registration of Corporation Service Company was fraudulent and unauthorized. Lacking authority or agency, Mr. Waxman changed the the registered office, registered agent, or our Tax ID number to his Tax ID number.

I, Dr. Priscilla Wade, am the President and owner of A & W Management, LLC. Ms. Amanda Warnick is our Registered Agent. Dr. Ifiker Ahmad maintains and manages our financial records. I am grateful that the Florida Division of Corporations notified Dr. Ahmad of this malicious event. Neither I, Dr. Ahmad, nor Ms. Warnick have ever met or contacted Mr. Waxman. Additionally, Mr. Waxman has never contacted A & W Management, LLC. Mr. Waxman is not an agent of A & W Management, LLC in any capacity. Furthermore, Mr. Waxman has never received authority to complete any filings on behalf of our company, A & W Management, LLC, in any capacity.

I filed the correct information identifying Ms. Amanda Warnick as our registered agent for A & W Management, LLC, of which I am the President and owner. **Therefore, I am formally requesting the immediate removal and correction of all information changed in consequence of Mr. Waxman's fraudulent actions.** This would include the immediate removal of Mr. Brian K. Waxman, 11780 US Highway One, Suite 305, North Palm Beach, FL 33408, our account and annual filing report immediately. The immediate removal of Corporation Service Company, 1201 Hays Street, Tallahassee, FL 32301 in our filings. Additionally, this would include the immediate correction of all information added, modified or removed as consequence of Mr. Waxman's fraudulent filing. Mr. Waxman and the Corporate Service Company neither had agency nor authority to complete any paperwork, modify any information, or file anything on behalf to A & W Management, LLC.

Please correct all the reported and relevant fraudulent information that occurred in my account in consequence of the fraudulent filing. The email we received from the Florida Division of Corporations reported the filing to have taken place on February 8, 2025, with the Secretary of State: 8669702490CC.
