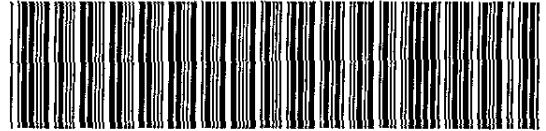



ARTICLES OF INCORPORATION

OF

ARTICLE 1. - NAME

The name of the corporation is SHADDY HRH, INC.

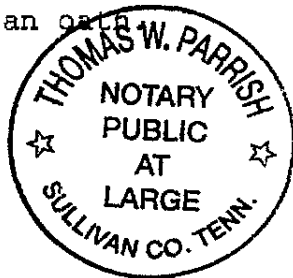
