Pursuant to Section 607.1006(1) of the Florida Statutes, the Articles of Incorporation of Sponsler & Bennett, a Florida corporation (the "Corporation") are hereby amended as follows:

1. The Articles of Incorporation of the Corporation were filed by the Secretary of State of the State of Florida on November 30, 1999. Articles of Amendment to the Articles of Incorporation were filed with the Secretary State of the State of Florida on February 24, 2000.
2. These Articles of Amendment amend the provisions of the Articles of Incorporation as amended by the Articles of Amendment filed on February 24, 2000.
3. The new name of the Corporation is Sponsler, Bennett, Jacobs & Cristal, P.A.
4. Article I of the Articles of Incorporation of the Corporation is hereby amended, in relevant part, to read as follows:

**Article I
Name**

The name of the Corporation is Sponsler, Bennett, Jacobs & Cristal, P.A.

5. The foregoing amendments were adopted on January 6, 2003, by the written consent of the shareholders of the Corporation in accordance with the provisions of Sections 607.1003(6) and 607.0704 of the Florida Statutes.
6. The sole voting group entitled to consent in writing to these amendments is comprised of the holders of common stock, and the number of votes cast for the amendments by the written consent of that voting group was sufficient for approval by it.
