PURSUANT TO CHAPTER 48.091, FLORIDA STATUTES, JAMARK A. SPENCE OF 455 DOUGLAS AVENUE, STE 2155-32, ALTAMONTE SPRINGS, FLORIDA 32714 IS HEREBY NAMED AS REGISTERED AGENT OF THIS CORPORATION TO ACCEPT SERVICE OF PROCESS WITHIN THE STATE OF FLORIDA. THAT JAMARK A.
